O R D E R

Mr. Pawanshree Agrawal, learned Amicus Curiae states that as on date out of 352 home buyers, only 237 have volunteered to take refund and the remaining 115 have not responded so far. He submits that it would be appropriate to fix some timeline within which the remaining 115 home buyers should exercise their option.

We find force in this suggestion. Accordingly, we permit the learned Amicus Curiae to fix timeline of two months from today to enable the remaining 115 home buyers to exercise their option. That be notified on the website created by the Amicus Curiae and in addition by email, if the email of the concerned home buyer is available.

List the matter after two months.

Relief claimed in the I.A. No. 159549 of 2018 will be considered at the appropriate stage.
